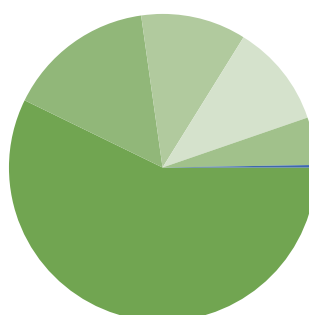

## About the Fund

The Fund is a money market fund that seeks to provide current income through low-risk investments. Also, the Fund seeks to maintain a \$1.00 per share net asset value.

The Fund purchases liquid, high quality, short-term debt securities in U.S. dollar- denominated money market instruments. The securities must have a maturity period of no more than 397 days and, in the opinion of the Fund's Investment Manager, present minimal credit risk.

The Fund's principal investments are: commercial paper; short-term corporate obligations; certificates of deposit; time deposits; and shares of investment companies that invest exclusively in the same types of securities as the Fund (up to 10% of the Fund's total assets, with no more than 5% in any individual investment company).
